Furthermore, you are all on notice, having now recognized who I truly am, being:-

Denis-Peter, standing as a sui juris, being the sole Beneficiary of the DENIS PETER RAWLINSON Trust & Estate, having now corrected the records, which was done on more than three consecutive occasions, endorsed by Mark Pitt the Chief Executive Officer acting for and on behalf of all the SOUTH BURNETT REGIONAL COUNCIL, ABN-89972463351; DUNS-757803718, Actors, and third party interlopers, and the Queensland office of local government;
